Background & Context

With the upcoming adoption of the **ISSB Climate Standard (IFRS S2)** in Malaysia, **Scope 3 emissions disclosure will become mandatory** for public listed companies. Scope 3 emissions – typically represent over **70% of a company's total carbon footprint** (depending on industries), yet remain the most complex and misunderstood.

While many trainings cover the “what” of Scope 1, 2 and 3, this session is differentiated by its focus on the “**how**” of Scope 3 quantification, drawing from real-world implementation experience, current frameworks like **PACT** and proven best practices to prepare for **audit-ready ISSB-aligned reporting**.

1. Practical Methodology Application	Covers multiple Scope 3 quantification methods (e.g. supplier-specific, spend-based, average data) with real application examples and decision logic

3. Boundary Clarity	Clarifies commonly misunderstood issues such as boundaries for emission factors (e.g. Suppliers Scope 1&2 Emission Intensity vs Supplier’s PCF Cradle to Gate)

5. Operationalisation	How to prioritise suppliers, apply AI for product mapping, automate transport & distribution category logic using Incoterms
